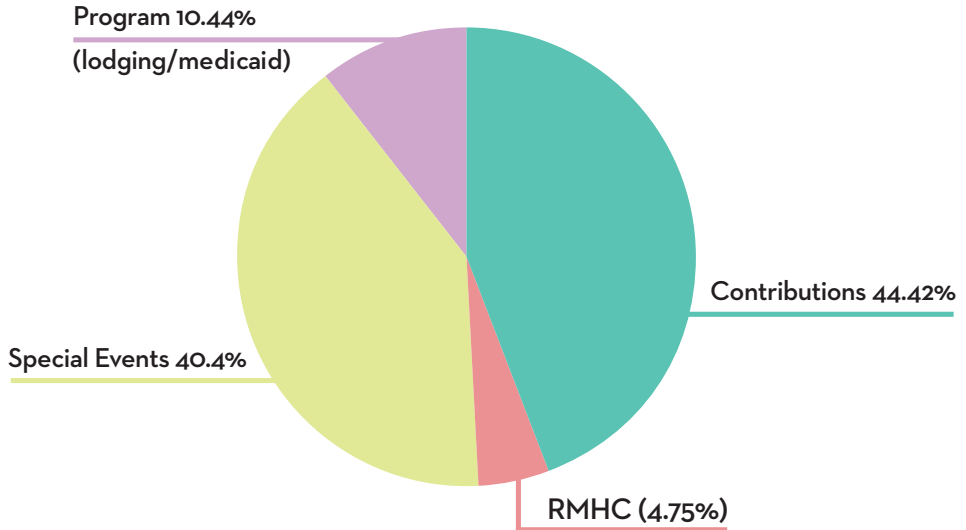

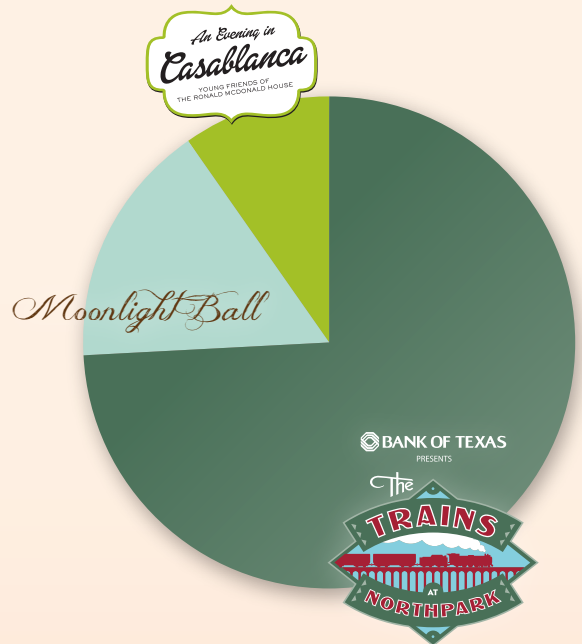

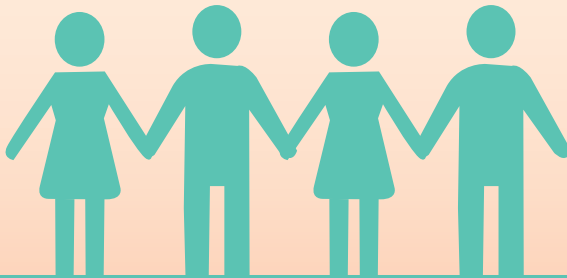

## Meals That Heal

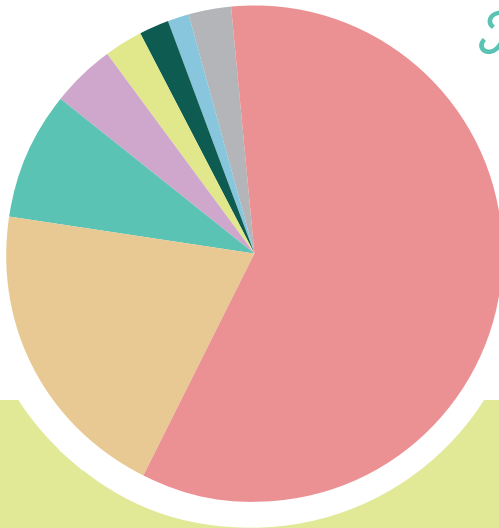

## Our Rooms

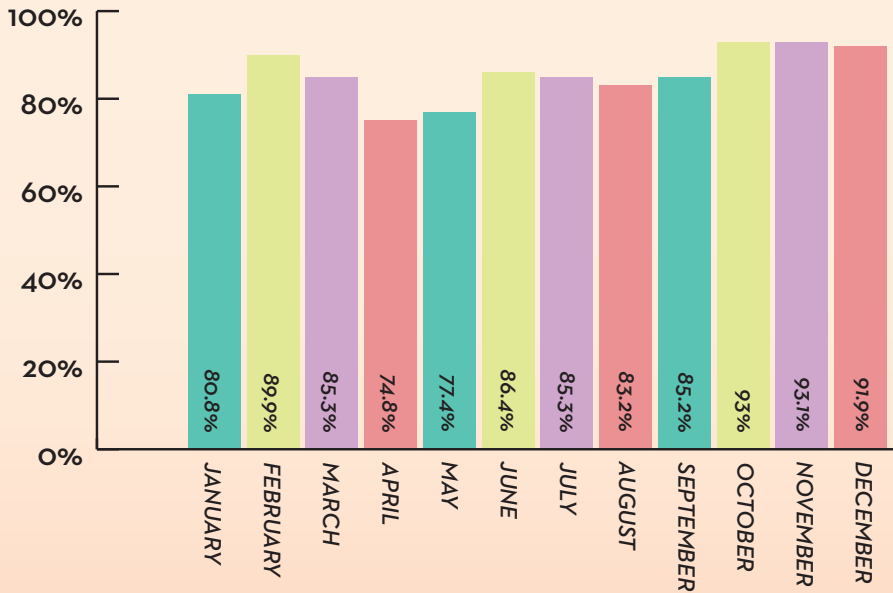
With 6 apartments dedicated to transplant patients and 52 guest rooms Ronald McDonald House of Dallas was able to provide over 1,900 family stays in 2013. It is a joy to be able to serve so many families and provide a temporary home where children and families can heal together. Since opening our doors, RMHD has served more than 34,000 families. Although families are asked to contribute \$15 per family per night, no one has ever been turned away because of an inability to pay. The actual cost per night to house a family is approximately \$125—a cost largely covered by individual and corporate donors, community organizations, and special events. We are appreciative of our dedicated community that continues to make our mission possible and serve families in need.
